**Section 5: FIRE-FIGHTING MEASURES****FLAMMABILITY AND EXPLOSION INFORMATION**

May intensify fire; oxidizer. Will burn if mixed or contaminated with combustible materials and exposed to heat. In addition, will accelerate the burning of other combustibles, resulting in more rapid spread of fire. Will not spontaneously combust. **Suitable Extinguishing Media:** Small Fire: Use water.
